About the Bean Foundation

History

Norwin S. Bean was born in Manchester, New Hampshire in 1873 and was graduated from the Massachusetts Institute of Technology with a degree in electrical engineering. He served as Treasurer and Chief Executive Officer of Manchester Savings Bank and was a prominent business and civic leader. His charitable activities included the Manchester Community Chest, Family Service Society, the Institute of Arts and Science, and the Currier Gallery.

Elizabeth N. (Nichols) Bean was born in Amherst, New Hampshire and was a member of the Amherst Congregational Church. She was active in many charitable organizations, including the Amherst Visiting Nurse Association and Amherst Historical Society. The Bean Foundation began operations upon her death in 1967.

Governance

The Bean Foundation is governed by two Senior Trustees who serve fifteen-year terms and three Term Trustees appointed for three-year terms. The Board of Trustees makes the final decision on all grant applications. It also oversees the Foundation's investment portfolio, currently managed by Goldman, Sachs & Co.

2010 Grants

The Norwin S. and Elizabeth N. Bean Foundation awards grants to nonprofit organizations and public agencies working in arts and humanities, education, environment, health, human services, and for public benefit in the communities of Manchester and Amherst, New Hampshire. The Foundation received 69 requests totaling \$1,173,254 and awarded 33 grants totaling \$408,538 in 2010. In addition, eight education mini-grants were awarded to Manchester public schools for a total of \$4,188 through the Foundation's Educational Enhancement Fund. Five grants benefitted Amherst residents, five benefitted the residents of both communities, and the remaining 23 awards went to nonprofits whose requests supported the residents of Manchester.

Historically, the Bean Foundation has generally funded the largest number of grants each year in the category of human services. In 2009, due to the challenging economy and the range of requests that were submitted, there was a 25 percent increase in human service grants over the previous year. In 2010, there were fewer grants awarded in human services, but a 50 percent increase in awards in education.

Ten grants, almost a third, sought to support immigrant and refugee needs. Four were in the area of human services. Of the 6 that were awarded in education, three were directed at youth learning and three at adult educational needs. The grants to English for New Americans and the Holy Cross Family Learning Center both supported English language learning and cultural training for adults who are recent refugees or immigrants. The grant to the Granite State Organizing Project supported leadership training for a diverse group of adults living in the Elmwood Gardens Housing Project, including volunteer time in the neighborhood elementary school where participants learned to prepare their children to be successful in school.

Bean Trustees supported four capital requests. Among those, Neighborhood Housing of Greater Manchester received a small grant and a loan to support development of 28 units of affordable housing in Amherst. Camp Allen received a grant toward its capital campaign to rebuild the camp, which is a summer camp for people with disabilities. Bean Trustees also supported the purchase and outfitting of a new building for the New Hampshire Food Bank.

The 2010 Annual Meeting of the Norwin S. and Elizabeth N. Bean Foundation was held at the Amherst Town Library, where non-profit leaders, former Trustees, and invited guests heard two stimulating presentations. The executive director of SHARE spoke on how the organization's new facility is helping to meet the region's food, shelter, and emergency needs in a challenging economy, and representatives of NHPR spoke on the eighteen month project the station is undertaking to explore the past, present, and future of immigration in New Hampshire.

Applications must be received by 5 p.m. or postmarked on the following dates for consideration at the next Trustee meeting. If the deadline falls on a federal holiday or weekend, applications are due on the next business day.

Educational Enhancement grant applications may be submitted at any time during the year, but projects must be completed during the school year. Applicants will receive a response within three weeks of submitting the application.
