History

Norwin Sherwood Bean was born in Manchester, New Hampshire in 1873 and graduated from the Massachusetts Institute of Technology with a degree in electrical engineering. He served as Treasurer and Chief Executive Officer of Manchester Savings Bank and was a prominent business and civic leader. His many charitable activities included the Manchester Community Chest, Family Service Society, the Institute of Arts and Science, and the Currier Gallery.

Elizabeth Nichols Bean was born in Amherst, New Hampshire and was a member of the Amherst Congregational Church throughout her life. She was active in many charitable organizations, including the Amherst Visiting Nurse Association and Amherst Historical Society. The Bean Foundation began operations upon her death in 1967.

Governance

The Bean Foundation is governed by two Senior Trustees who serve fifteenyear terms and five Term Trustees appointed for five-year terms. The Board of Trustees makes the final decision on all grant applications. It also oversees the Foundation's investment portfolio, which was managed in 2022 by Northern Trust.

2022 Report of the Trustees

In 2022, Kris McCracken served as chair of the seven-member trustee board. Kris' expertise in healthcare was invaluable during the pandemic and her understanding of community health needs helped the trustees make important funding decisions. Michael Delaney served as past chair and Rashida Mohammed joined as a new trustee for a five-year term.

The Foundation received 41 grant requests and funded 30 grants totaling \$599,193. An additional grant of \$25,000, was made to Manchester Proud through the Foundation's donor advised fund.

In 2022 the Trustees funded requests in five of the Foundation's six grant-making categories. They were health, human services, arts & culture, education, and public benefit. Human services and education received the most grants, followed by public benefit and health, largely because those were the categories in which the most requests were submitted, but also based on need and the qualities of the requests submitted. Two grants benefitted Amherst, twenty-four were targeted at Manchester and four supported both communities.
