# **History**

Norwin Sherwood Bean was born in Manchester, New Hampshire in 1873 and graduated from the Massachusetts Institute of Technology with a degree in electrical engineering. He served as Treasurer and Chief Executive Officer of Manchester Savings Bank and was a prominent business and civic leader. His many charitable activities included the Manchester Community Chest, Family Service Society, the Institute of Arts and Science, and the Currier Gallery.

Elizabeth Nichols Bean was born in Amherst, New Hampshire and was a member of the Amherst Congregational Church throughout her life. She was active in many charitable organizations, including the Amherst Visiting Nurse Association and Amherst Historical Society. The Bean Foundation began operations upon her death in 1967.

#### Governance

The Bean Foundation is governed by two Senior Trustees who serve fifteenyear terms and five Term Trustees appointed for five-year terms. The Board of Trustees makes the final decision on all grant applications. It also oversees the Foundation's investment portfolio, which was managed in 2023 by Northern Trust.

# 2023 Report of the Trustees

In 2023, Bob Heaton served as chair of the seven-member trustee board. Bob's business background and his experience serving on non-profit boards brought unique insight to our grantmaking process.

The Foundation received 49 grant requests and funded 31 grants as well as educational enhancement grants totaling \$598,726.

In 2023 the Trustees funded requests in all six of the Foundation's six grant-making categories. They were health, human services, arts & culture, education, environment, and public benefit. Education and human services received the most grants, based on need and the quality of the requests submitted. Two grants benefitted Amherst, twenty-six were targeted at Manchester and three supported both communities.

The Trustees embarked on a strategic planning process in 2023 which began with a full day retreat. The two major questions considered were: What Does the Bean Foundation Value as an Organization? and How Should We Structure the Foundation for Continued Success?

As a result of the day's work, the Trustees created a Vision and Impact Statement, which was approved at the June 2023 meeting.

#### Vision and Impact Statement

- 1. Through our grantmaking, we will invest in the communities of Manchester and Amherst, New Hampshire.
  - a. We will continue to honor the broad mission of Norwin S. and Elizabeth N. Bean when they created a foundation to support the arts & humanities, health, human services, education, the environment, and public benefit.
  - b. Our grantmaking will be strategic, active, and engaged.
  - c. We will make decisions that will improve the communities we serve.
- Our multi-faceted grantmaking will help address the communities' greatest needs.
  - a. We will learn and listen to deeply understand the communities.

- b. Our grantmaking will be innovative and may involve risk-taking.
- c. We will look for opportunities to make larger and longer commitments to target significant needs.
- d. We will work with partners to produce the greatest impact.
- 3. In all our work, we will demonstrate the best practices of stewardship.
  - a. We will work with sound advisors to ensure the Foundation's assets are prudently invested and managed.
  - b. We will keep abreast of best practices in grantmaking by attending workshops and seminars, participating in professional associations, and by becoming familiar with the work of our grantees.
  - c. We will build trusting relationships with grantees, colleagues, and community members.

Trustees will continue to work on and enact this plan in the years ahead as they consider every aspect of their grant making.
